THE VILLAGE: Conejo Valley Village, a tax-exempt nonprofit corporation under §501(c)(3) of the Internal Revenue Code, is a community-based network of neighbors in Conejo Valley.

SERVICES/PROGRAMS: The Village provides services and programs for Full Members through its corps of volunteers. All volunteers submit to background checks. Any services that cannot be provided through our volunteers, such as major home repairs, home inspections and home health-care needs, the Village will assist Members in finding a qualified provider. The Village provides social and educational programs for Social Members.

MEMBERSHIP: Membership acceptance occurs when an application and agreement is submitted by the prospective member, the prospective member has met with a village membership representative, attends a member orientation and the first dues payment has been received. Membership may be renewed subject to agreement of the Member(s) and Conejo Valley Village and payment of the then-applicable annual dues.

DUES: The annual dues for Full Membership in the Village are \$600 for an individual and \$900 for a household of up to three Members. The annual dues for a Social Membership is \$180 for an individual member. Dues can be paid monthly, quarterly, or annually. Membership runs for a 12-month period beginning on the first day of the month following the member's acceptance by the Village. Membership dues cover volunteer services provided for Full Members and social events and programs organized by CVV. Membership dues cover social events and programs for Social Members. Additional fees may be necessary for certain events and outings.

MEMBER AND VOLUNTEER HANDBOOK: I understand the member/volunteer handbooks are available on the CVV website at <u>www.conejovalleyvillage.org</u> and it is my responsibility to read the handbook, and become familiar with the contents. A copy of the handbook is available upon request.

TERMINATION OF AGREEMENT: The Village reserves the right, at its sole discretion, to terminate this agreement, at any time, if the Village determines that it is in the best interest of the Village, its volunteers, other Members, or the undersigned Member. If the membership is terminated, CVV will return the unused portion of prepaid dues. The undersigned Member(s) may terminate this agreement at any time by providing written notice to the Village.

PHOTO RELEASE: The undersigned approves the use of his/her name and photograph for publicity purposes, including but not limited to, brochures, newsletters, website postings and for release to local newspapers. No home address, email or telephone number will be included in any publication. I understand CVV retains the right to use photographs, slides or video-taped materials of me taken during activities for promotional purposes and waive all rights for compensation.

PRIVACY: The Village will take all reasonable steps to protect the personal information of its Members. However, where concerns regarding a Member's health or safety arise, the Village reserves the right to contact the individual(s) listed as the Member's emergency contact/personal contact listed on application. In addition, to connect a Member with a third-party vendor at the Member's request, the Village may disclose contact and other relevant information.

CVV DOES NOT PROVIDE HEALTHCARE SERVICES: I understand that the Village is not a provider of emergency services or health care services, is not a health-care administrator, and does not employ licensed health professionals or social workers. This Agreement is not meant to create any special relationship giving rise to a duty to aid or protect between myself and Conejo Valley Village.

WAIVER OF LIABILITY: I agree to defend, indemnify and hold harmless the Conejo Valley Village and its officers, employees and agents against any and all loss, liability charges, expense (including attorney fees) and costs of whatsoever character which may arise by reason of participation in any program or activity.
